

## NOTICE

It is to inform to the candidates who have applied for the post of Peon/Addl. Peon purely on Ad-hoc basis in pursuant to the advertisement notice dated 22.01.2026 published in the newspapers "Times of India" and "Punjab Kesri" that interview for 10 posts of Peon/Addl. Peon purely on Ad-hoc basis shall be conducted from 05.03.2026 to 13.03.2026.

A total of 6081 application forms were received in this office till last date i.e. 10.02.2026. On scrutiny, 6049 candidates were found provisionally eligible for interview. The list of such eligible candidates has been prepared in alphabetic order which is annexed herewith as **Annexure 'A'** and the serial number of that alphabetical list has been allotted as Roll Number to the candidate. During the course of scrutiny, various discrepancies were found in 32 application forms, details of which are annexed herewith as **Annexure 'B'** and 395 application forms were received after last date of submission of application forms i.e. 10.02.2026, details of which are annexed herewith as **Annexure 'C'**. Candidature of all the applicants whose names mentioned in the **Annexure 'B'** and **Annexure 'C'** have been rejected as per terms and conditions of the advertisement notice dated 22.01.2026.

It is further informed that the said list Annexure-A is provisional subject to further scrutiny of all the documents of the candidates to be produced at the time of interview. Hence, all the candidates appearing for interview are required to bring their original testimonials with regard to their education qualification, age, caste certificate etc. or any certificate claiming for any reservation along-with one set of photocopies duly self-attested and photo identity proof (such as aadhar card, driving license, voter card etc.).

The Committee reserves its right to cancel the candidature of any candidate whose documents are not found in order.

The following criteria which would carry maximum 30 marks shall be observed by the Sub Committees while conducting the interviews. The candidate who secures 10 marks in aggregate shall be deemed to have been qualified in the interview. However, it shall not confer any right to the candidate for the appointment to the said post.
