Gujarat Metro Rail Corporation (GMRC) Limited, a 50:50 Special Purpose Vehicle (SPV) jointly owned by Government of India and Government of Gujarat is entrusted with the responsibility of implementation of Ahmedabad Metro Rail Project Phase-I, Phase-II and Surat Phase-I and its Operations & Maintenance.

2. SELECTION PROCESS

- The selection process will comprise of Personal Interviews followed by Document Verification and Medical Examination as per the category prescribed for the post.
- Preference shall be given to candidates who have experience in same grade/or immediate lower grade with 2

- years' experience in the grade. In case sufficient number of suitable candidates are not available for the advertised post, candidates from lower pay scale who meet the prescribed qualifications, total experience, and age criteria may be considered to fill the vacancy.
